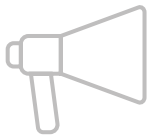

VALJEVO	Improvement of economic infrastructure in the economic zone of Valjevo	Total value: 132,775 Euros EU PRO Plus: 132,775 Euros Co-funding: -	The project equips the Valjevo business zone for investment and job creation. It includes road construction, parking lots, lighting, and drainage and improved Zone management.
2.	ŠABAC	Equipping Northwest Work Zone for new development perspectives of the City of Šabac	Total value: 1,463,075 Euros EU PRO Plus: 619,957 Euros Co-funding: 843,118 Euros	The project finalises the development of the Northwest business zone in Šabac. It involves constructing sewage systems and roads.
3.	ĆUPRIJA	Construction of a distribution transformer station in the "Minel" industrial zone	Total value: 198,291 evro EU PRO Plus: 168,547 Euros Co-funding: 29,744 Euros	The project upgrades the "Minel" industrial zone by improving power supply capacities.

NOVI PAZAR	Construction of Regional Smart City Centre in Novi Pazar – Phase II	Total value: 408,085 Euros EU PRO Plus: 321,344 Euros Co-funding: 86,741 evro	The project establishes a Smart City Centre with 1,050 m of space for the IT industry. It benefits companies, citizens, and promotes women's employment.

BOSILEGRAD	Reconstruction and rehabilitation of the "Kobos" factory	Total value: 337,044 Euros EU PRO Plus: 303,340 Euros Co-funding: 33,704 Euros	The project envisages the reconstruction and equipping of the former textile plant "Kobos" in the ownership of local self-government for the purpose of its leasing to a new potential investor.

KRAGUJEVAC	Rehabilitation of the road-pedestrian bridge in the "FAS" free zone	Total value: 723,886 Euros EU PRO Plus: 506,648 Euros Co-funding: 217,238 Euros	The project envisages reconstruction of the road pedestrian bridge over the Lepenica river in the FAS zone along with hydrotechnical and telecommunication installations used by 17 companies employing over 4,000 workers with two new companies planning to invest 200 million Euros and to employ 500 workers. The development of technical documentation was funded through the EU PRO Programme.

The facility offers treatment, rehabilitation, and modern physical therapy with specialised assistance. It has a wastewater treatment plant and utilises heat pumps for heating and cooling.

ALEKSINAC	The reconstruction of Institution for rest and recreation of children "Lipovac"	Total value: 618,629 Euros EU PRO Plus: 381,983 Euros Co-funding: 236,646 Euros	The project reconstructs the Institution for rest and recreation of children "Lipovac" to modernise and enhance its infrastructure. It provides improved services for various beneficiaries, including sports clubs, NGOs, pensioners, and tourists.

MALI ZVORNIK	Improvement of tourism infrastructure in Mali Zvornik	Total value: 154,838 Euros EU PRO Plus: 139,354 Euros Co-funding: 15,484 Euros	The project expands the tourist offer via construction of a 950 m walking trail with three view and resting points to the archaeological site of Orlovine and establishment of an info-centre for promotion and exhibition of artefacts. The project also includes capacity-building programmes for tourism development and promotion, along with the development of a Tourism Promotion Plan.

UŽICE	Reconstruction of the Water Tower at the mediaeval Old Town fortress in the City of Užice	Total value: 925,646 Euros EU PRO Plus: 381,983 Euros Co-funding: 543,662 Euros	The reconstruction of the water tower at the mediaeval Old Town fortress in Užice creates conditions for tourism development with impact on a wider number of small businesses in the area indicating potential for employment of 60 people. The project presents continuation of the City of Užice efforts to revitalise the fortress, among which the detailed regulation plan was developed within the EU PRO Programme.
