Objective Support for the employment of women and youth from underdeveloped municipalities in the regions of Šumadija, Western Serbia, Southern Serbia, and Eastern Serbia through the provision of equipment and services for starting businesses, as well as strengthening young enterprises.

Eligibility Criteria

LOT 1 Unemployed women and youth aged 18 to 30, who, at the time of publishing of the public call, have been **registered** with the National Employment Service and have a permanent residence and plan to start a business in one of **43 Programme local self-governments*** from Category IV of development.

LOT 2 Women and youth entrepreneurs and micro and small enterprises (MSEs), owned by women or youth (18-30), registered in 2022 and after in one of **43 Programme local self-governments*** from Category IV of development.

The inhabitants of the 99 cities and municipalities are the final beneficiaries of the Programme.

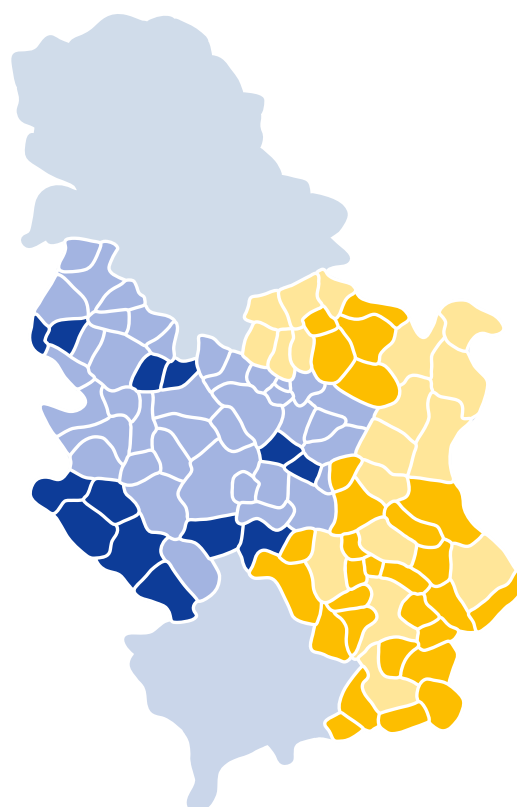
